Concerning the Regulation of the Use of  
Antibiotics in Health Facilities  
and the Regulation of the Use of

1.	General Provisions	1.	1.	This Regulation is formulated to regulate the use of antibiotics in health facilities.
2.			This Regulation applies to all health facilities.	
2.	Definitions	2.	1.	Antibiotic is a substance that can kill or inhibit the growth of bacteria.
2.			Antibiotic resistance is the ability of bacteria to resist the effects of antibiotics.	
3.	Principles	3.	1.	The use of antibiotics must be based on the principle of rational use.
2.			The use of antibiotics must be based on the principle of safety.	
4.	Responsibilities	4.	1.	The Ministry of Health is responsible for formulating and implementing this Regulation.
2.			Health facilities are responsible for implementing this Regulation.	
5.	Penalties	5.	1.	Health facilities that do not comply with this Regulation shall be subject to administrative sanctions.
2.			Individuals who do not comply with this Regulation shall be subject to administrative sanctions.
